#### **Project Description:**

Improvements to the Headworks and Wet Weather Flow Equalization at the Back River WWTP (Project or Sanitary Contract No. 918H) are intended to address stormwater run-off where large quantities of precipitation during storm events can inundate the wastewater system, causing backups and overflows. The project will pump sewage from chronically backed up mains into the treatment plant and help prevent sewage overflows in the City.
