### General Project Information:

The project provides for the construction of a terminal expansion with approximately 225,000 sf of new & renovation of existing construction with the majority of work occurring between Concourse D and Concourse E. The primary components include the widening and renovation of the "throat" portion of Concourse D in order to comply with current life safety and building code requirements; the construction of a new D/E Connector with a separate "sterile corridor" to the International Arrivals area in Concourse E; the reconfiguration of two (2) existing domestic gates into two (2) gates that will be capable of servicing either international or domestic flights; and the construction of an eight (8) lane passenger security screening checkpoint. The project will involve all building trades and specialty work associated with airport terminal facilities. Work includes demolition, excavation, reinforced concrete, structural steel framing, curtain wall, drywall, interior finishes, freight elevators, air handling units and distribution and piping systems, fire protection systems, plumbing systems for new restrooms and building maintenance, new electrical substation, generator and distribution systems, telecommunications, data and security systems, pavement reconstruction and new loading docks.
