Project Description: The Purple Line Project includes a 16.2 mile, 21-Station, east-west, light rail transit (LRT) Transitway that will extend from its western terminus just west of Wisconsin Avenue and the Bethesda Metro Station to is eastern terminus at the New Carrollton Metro Station. The Transitway will be largely at grade with one short tunnel section, three sections elevated on structures and several bridge structures. The Transitway will operate mainly in dedicated or exclusive lanes. In addition to the 21 transit stations, there will be two maintenance facilities, one located near Lyttonsville and the other near Glenridge.
