The project will involve all building trades and specialty work associated with airport terminal facilities. Specific elements of the project include underground utilities, concrete pavement, reinforced concrete and structural steel framing; architectural curtainwall and building envelope systems; one moving walkway and two elevators; air handling units with distribution and piping systems; fire protection systems; plumbing systems; a new electrical substation; telecommunications, data, and security systems; passenger boarding bridges, PC Air and 400 Hz; baggage handling systems.
